19 REBECCA SCHULTZ, being first duly sworn, deposes and says as follows:

- 20 1. That I am the daughter of the Ward and a resident of the State of California.
21 2. That when Jared Shafer was initially appointed as my father's guardian, it was
22 by mutual understanding that Mr. Shafer would remain as guardian for a limited short time,
23 and that I would take over as guardian.
24 3. That on November 25, 2009, I met with Jared Shafer at my father's home
25 located at 2050 Mountain City Street, Henderson, Nevada.
26 4. Upon my inquiry that evening of when I could expect to become my father's
27 guardian, Mr. Shafer responded by saying, "It could be 2 or 3 months, no more than 6 months
28 for me to 'package things up'. I don't like holding on to these kind of cases long."

1 5. I found this terminology of packaging my father's guardianship offensive as
2 if he were a mortgage, rather than a person.

3 6. Without provocation, Mr. Shafer then said, "I don't even have to show up in
4 court, the judge always gives me what I want."

5 7. To this alarming statement I responded, "What, are you giving the judge kick-
6 backs?" Mr. Shafer and Patience Bristol, his caseworker who was also there at the time, then
7 looked at each other and chuckled.

8 8. At the time I did not know what to think of these comments but I felt they
9 were improper. Throughout this process of seeking to become my father's guardian it is
10 apparent to me that Mr. Shafer does receive preferential treatment. I feel it is important for
11 the Guardianship Commissioner to be aware that Mr. Shafer speaks about him in this
12 manner.
