- 8. At the time I did not know what to think of these comments but I felt they were improper. Throughout this process of seeking to become my father's guardian it is apparent to me that Mr. Shafer does receive preferential treatment. I feel it is important for the Guardianship Commissioner to be aware that Mr. Shafer speaks about him in this manner.
- 9. Further your affiant sayeth naught.


