Court and Counsel engaged in discussion regarding the issue as to whether a guardianship over Mr. Hanson was necessary once he emancipated. Court reviewed the history of the case, indicating that

the minor guardianship ended over seven years ago and an adult guardianship was never put in place. Arguments by Counsel. Court finds that this Court lost jurisdiction over the matter when the ward turned 18.

Court requested Mr. Bell stress to Mr. Hanson that the Court is willing to address any questions or concerns he has and that there are remedies available to him even though this Court no longer has jurisdiction over the matter.

COMMISSIONER RECOMMENDED, as follows:
