17 The Court, having reviewed the Errata to the First and Final Account of Guardian, Report
18 of Guardian and Petition for Distribution, Fees and Discharge and Errata thereto, filed by Petitioner,
19 Jared Shafer, on January 29, 2013, by and through his counsel, the law firm of SOLOMON
20 DWIGGINS & FREER, LTD., and pursuant to the Court Order filed February, 14, 2013 an
21 Objection having been filed to the Errata by the California Conservator, by and through his attorney,
22 JOHN C. COURTNEY of the Law Office of JOHN PETER LEE, filed February 6, 2013, and a
23 Reply to the Errata having been filed by Petitioner, Jared Shafer, on February 15, 2013, by and
24 through his counsel; the hearing have been noticed and Set by the Clerk of the above-entitled Court
25 for the 3rd day of April, 2013, at 9:00 a.m., having examined the evidence, and heard the oral
26 arguments of counsel, and being fully advised in the premises finds: (i) proper notice of the hearing
27 was duly given as required by law; (ii) but for Jared E. Shafer's billing entry for anticipated time for
28 the court hearing on January 30, 2013, the fees and costs incurred by Jared E. Shafer are necessary,

1 reasonable and incurred for the benefit of the Ward and/or his Estate, (iii) to expedite the closure of
2 this matter, Jared E. Shafer's counsel agreed to waive its fees and costs for the period of January 6,
3 2013, to April 3, 2013, (iv) the fees and costs incurred by Jared E. Shafer's counsel are necessary,
4 reasonable and incurred for the benefit of the Ward and/or his Estate, and any alleged reduction
5 thereto would be offset by the fees and costs being waived by Jared E. Shafer's counsel, (v) the fees
6 and costs of Jared E. Shafer and his counsel should be paid by William Chaddock, as Trustee of the
7 Ward's Trust, (iv) and the remaining issues in the Guardian's First and Final Account of Guardian,
8 Report of Guardian and Petition for Distribution, Fees and Discharge filed October 9, 2012, having
9 been previously confirmed by Court;

10 At a hearing on January 30, 2013, the Court having held that: the First and Final Account of
11 Guardian was approved; that the guardianship shall be terminated in sixty (60) days in favor of the
12 California Conservatorship if no further requests for relief were pending; that Jared Shafer was to
13 transfer all records to the California Conservator; that the bench warrant of Rebecca Shultz shall be
14 quashed; that the California Conservator was to submit a line item response to Mr. Shafer's request
15 for additional attorney's fees; and that Mr. Colucci's request to withdraw as counsel for the Ward
16 shall be granted; and as of the date of this Order, there exist no further request for relief in this case,
17 and there exist no good cause to preclude the Court from terminating the guardianship in favor of
18 the California Conservator upon the issuance of this Order;

19 **IT IS ORDERED, ADJUGED AND DECREED** that the fees and costs incurred by Jared
20 E. Shafer, for work performed on behalf of the Guardian in connection with the guardianship of
21 Guadalupe Olvera between September 28, 2012 and January 28, 2013, in the amount of \$1,354.17
22 are hereby approved.

23 William Chaddock, as Trustee of the Ward's Trust and Conservator of Mr. Olvera's Estate,
24 or any successor trustee and/or conservator thereto, is hereby authorized and directed to pay Jared
25 E. Shafer in the amount of \$1,354.17.

26 **IT IS FURTHER ORDERED, ADJUGED AND DECREED** that the fees and costs
27 incurred by the law firm of Solomon Dwiggin & Freer, Ltd., for work performed on behalf of the
28 Guardian in connection with the guardianship of Guadalupe Olvera between October 1, 2012, and

1 January 25, 2013, in the amount of \$6,332.10 are hereby approved.
2 **IT IS FURTHER ORDERED, ADJUDGED AND DECREED** the guardianship of
3 Guadalupe Olvera shall be terminated upon the issuance of this Order.
4 **IT IS FURTHER ORDERED, ADJUDGED AND DECREED** the bench warrant of
5 Rebecca Shultz shall be quashed upon the issuance of this Order.
6 **IT IS FURTHER ORDERED, ADJUDGED AND DECREED** Jared Shafer shall within
7 ten (10) days transfer all of the records of the guardianship to the California Conservator, William
8 Chaddock.
9 **IT IS FURTHER ORDERED, ADJUGED AND DECREED** William Chaddock, as
10 Trustee of the Ward's Trust and Conservator of Mr. Olvera's Estate, or any successor trustee and/or
11 conservator thereto, is hereby authorized and directed to pay Solomon Dwiggins & Freer, Ltd. in the
12 amount of \$6,332.10.
